#### Spring Garden Lutheran Church Congregation Annual Meeting Minutes – 1/29/2023

The meeting was called to order by President Scott Safe at 10:56 am in the church sanctuary.

A quorum was established with a total of 47 voting members present.

The opening prayer was given by Pastor Tim.

Secretary's Report: President Scott asked for any corrections or additions to the Secretary's report. A motion was made by Dennis Sjoquist, seconded by Stephanie McLain and carried to approve the minutes of the April 24, 2022 congregational meeting.

#### **Financial Reports:**

*Audit Committee:* Tim Anderson reported that the Audit Committee found all of the accounts to be correct. *Financial Secretary:* Pam Davis reported that for 2022, the General Fund received \$211,453.97 in pledges and \$349,028.89 in total receipts. The Improvement Fund had a beginning balance of \$103,807.89 and an ending balance of \$157,321.97. *Treasurer:* Rob Lorentz reported that for 2022, the checkbook beginning balance was \$55,810.30 and the ending balance was \$50,902.42.

A motion was made by Glen Lundell, seconded by Darryl McLain and carried to approve the 2022 Financial Reports.

**Mission Endowment Fund Committee Report:** Paul Olson gave the Mission Endowment Committees' report. He noted that despite 2022 being a tough economic year, their funds earned about \$9,000 and they distributed over \$8,000. Over \$52,000 was brought in for 2022 through contributions, and a total of almost \$96,000 has been distributed to date. A motion was made by Larry Olson, seconded by Tim Anderson and carried to approve the Mission Endowment Fund Committee's report.

Committee's Reports: President Scott encouraged everyone to read the Committee Reports.

- **Pastors' Report:** Pastor Tim encouraged everyone to read his report. He noted that his first call as an Interim Pastor was at St. Ansgar's prior to his being called to Spring Garden to serve as our Interim Pastor. He has deeply appreciated the last five months that he has served here as our Pastor. He is impressed with the leadership, the staff, and the warm welcome from the members of Spring Garden. He relayed that he thought that Spring Garden is a congregation that is full of life. He feels that that is not true of all congregations in the ELCA. Therefore, he sees a great future for Spring Garden. Pastor Tim thanked us for the privilege to serve here as our Pastor, and to also help us follow a transition process resulting a newly called pastor for Spring Garden by next fall.
- Adoption of 2023 Budget: Rob presented the proposed budget for 2023. He noted that were increases in budgeted Good Earth Village Membership and Benevolent expenses because there has been no change in those budgeted expenses for many years. He also noted that because we are in a transition year between pastors, some anticipated expenses in the budget were based only on our best estimate. A motion was made John Olson, seconded by Nina Pagel and carried to approve the 2023 proposed budget of \$264,595.45.

#### **Old Business**

1. There was no old business.

#### **New Business**

- 1. *Transition Team Update:* Mark Sjoquist reported that the Transition Team is continuing with the weekly congregational surveys which will help them develop a Ministry Site Profile.
- 2. *Discussion on a Call Committee:* President Scott encouraged anyone that may be interested in serving on the Call Committee to let him or another council member know. He mentioned that the council plans on electing a Call Committee at their next meeting.
- 3. *Revised Gift Policy:* Stan Lundell spoke about revisions to the Gift Policy. He mentioned that the most significant revision addresses whether or not a donor's gift will remain anonymous.

Darryl McLain made a motion to elect all of the listed nominees. Tim Anderson seconded the motion and it carried.

- 5. President Scott announced the resignation of Vice President Don Anderson. For the time being, Don feels that he needs to devote much of his time to his family.
- Notice of positions up for election at the April Congregational Meeting: President Scott announced that the following council positions are up for election this year: a Vice President, a Faith Formation Board member, and a Missions Board member. Two Mission Endowment Fund Committee members are also up for election and also a member to serve on the Nominating Committee with the Executive Committee.

Adoption of Resolutions: President Scott read the resolutions as listed in the annual report. A motion was made by Paul Olson, seconded by Pauline Nerison and carried to accept the resolutions of the congregation for 2022.

Adjournment of Meeting: A motion was made by Larry Olson, seconded by Pauline Nerison and carried to adjourn. The meeting adjourned at 11:34 am.

#### Spring Garden Lutheran Church Council Meeting Minutes February 2, 2023

In Attendance: Scott Safe, Stan Lundell, Heidi Anderson, Ruthie Sjoblom, Becky Haugen, Christy Collins, Randy Benson, Pastor Tim, Financial Secretary–Pam Davis, and Treasurer–Rob Lorentz

**Call to Order:** President Scott Safe called the meeting to order at 6:01 pm in the church social hall. An opening prayer was given by Pastor Tim.

Based on Acts 15:28, Pastor Tim presented the council with questions regarding our vision for Spring Garden. Secretary's Report: A motion was made by Randy, seconded by Ruthie and carried to approve the minutes of the January 5<sup>th</sup> and the January 15<sup>th</sup> council meetings.

**Financial Secretary's and Treasurer's Reports:** Pam's report showed a total of \$ 12,417.00 in pledges for the month of January. Rob's report showed that the checkbook balance as of January 31<sup>st</sup> was \$51,485.32. A motion was made by Becky, seconded by Heidi and carried to approve the financial reports.

**Pastor's Report:** Pastor Tim mentioned that the mid-week Lenten services will be "Round Robin" with five area congregations participating.

### Action Items:

 Transition Team's Recommendations for the Purpose Statement and Guiding Principles: Mark Sjoquist, Transition Team Chair, presented a Purpose Statement and Guiding Principles that the Transition Team created utilizing information collected from the January 7<sup>th</sup> Mission and Guiding Principles Retreat.

A motion was made by Randy, seconded by Ruthie and carried to approve, as presented, the following Transition Period Purpose Statement and Guiding Principles.

#### **Transition Period Purpose Statement**

To respectfully build and strengthen our church family while allowing the Holy Spirit to guide us to a new pastor who will equip and empower Spring Garden for the future to spread the Good News of Christ in our community and the world. **Guiding Principles** 

Listen: Listen to the Holy Spirit and the people of our congregation to guide us through the process

Steadfastness: Be confident in our faith and future

Patience: Take time to identify what is important

Outreach: Be welcoming to all and reach out beyond our church

Vision: To acknowledge the past but look to the future, understanding that all things change

2) *Council Resignation:* Scott Safe announced that Don Anderson resigned as Vice President due to personal issues. He unfortunately feels that he needs to devote much of his time to other things for the time being. A motion was made by Randy, seconded by Ruthie and carried to regrettably accept Don's resignation.

Scott suggested Bjorn Olson as a possible candidate to fill the position. A motion was made by Becky, seconded by Stan and carried to appoint Bjorn Olson as Vice President to serve the remainder of Don's term.

3) Election of a Call Committee: The council received several excellent nominees that were willing to serve on the Call Committee. There were also two Transition team members that were interested in serving on the Call Committee. Our constitution requires a Call Committee of six voting members. The synod recommended that the Call Committee include additional members that serve as alternates, and also at least one member from the Transition Team. After the council considered their recommendations, the council decided that four alternate members would be appropriate.

A motion was made by Ruthie, seconded by Becky and carried to elect Transition Team members Mark Sjoquist and Jay Olson as two of the alternate members of the Call Committee.

The election of the Call Committee's six voting members and the remaining two alternates was done by paper ballot. The following members were elected to serve on the Call Committee: *Gideon Anderson, Val Haggstrom, Becky Haugen, Megan Nerison, Josh Olson, and Lowell Peterson were elected as the six voting members. Marcia Dicke, Jay Olson – Transition Team member, and Mark Sjoquist – Transition Team member were elected as the four alternate members. Vice President Bjorn Olson will serve as an ex officio member as is required by our constitution.

- 4) *Membership Transfer Request:* A motion was made by Randy, seconded by Heidi and carried to approve transferring the membership of David Roinas from Faith Lutheran Church in Rochelle, Illinois to Spring Garden Lutheran Church.
- 5) *Mission Endowment Approved Requests:* A motion was made by Heidi, seconded by Christy and carried to approve the following disbursements that the Mission Endowment Committee approved at their January 16<sup>th</sup> meeting.
  - Luther Seminary \$500
  - Faith Formation Board \$2,000 to provide funds to support the Scholarship Program
  - Support for School Supplies in Cambodia \$500 toward this effort. Chuill is in Cambodia and has initiated a fundraising campaign to provide school supplies in the town he grew up in (2 teachers for 508 students)
- 6) Set Date for Midsommar: June 25<sup>th</sup> was set as the date for our Midsommar celebration.
- 7) Set Date for Council to Serve Lenten Supper: The council will furnish and serve the meal for the March 22<sup>nd</sup> Lenten service.
- 8) *Remaining New Sign Funds:* A motion was made by Randy, seconded by Becky and carried to transfer the remaining funds, \$12,490.24, from the New Outdoor Sign Fund to the Building/Property Fund.
- 9) Church Calendar Review: June 25<sup>th</sup> Midsommar Celebration

#### **Board and Committee Reports**

*Worship & Music–Ruthie Sjoblom:* They met on January 9<sup>th</sup> to work on scheduling lay volunteers. They are also in need of more altar care volunteers.

They also met on January 15<sup>th</sup> to do planning on upcoming worship services. Final details are being worked out for the Lenten services.

The adult choir sang under the direction of our new Music Director, David Roinas, on January 29<sup>th</sup>. The youth choir will sing on Sunday, February 5<sup>th</sup>. They will also sing a special song that includes participation from the congregation.

Faith Formation-Becky Haugen: Rotational Sunday School will be held March 9th, 16th, 23rd, and April 2nd.

Seder Meal instruction classes for the 5<sup>th</sup> graders will be held on those Sundays, and the Seder Meal will be on April 5<sup>th</sup>. The flower sale fundraiser will soon be underway.

Senior Recognition Sunday will be held on May 7th.

Some new exciting things are being planned for Vacation Bible School this summer. More information to follow.

We will need more volunteers to chaperone the Summer Youth Works trip.

Parish Life & Outreach-Heidi Anderson: Nothing new to report.

*Church Property–Randy Benson:* Rachel cleaned up the memory on the PowerPoint computer to fix recent instances of it not functioning properly. Becky cleaned out our Zoom account to fix performance issues when using Zoom. Randy did several general routine maintenance projects.

Stewardship-Scott Hanson: Nothing new to report.

*Missions Board–Christy Collins:* They are looking for additional board members. Brenda Safe has decided resign from the Missions Board and serve on the Parish Life & Outreach Board. They have begun planning a mission trip back to Guatemala in January 2024. There are 14 people interested in going so far.

*Executive Committee:* They met with Rachel on January  $22^{nd}$  to develop a plan to review, and then recommend possible changes to the Administrative Assistant Job Description.

Because of the unfortunate resignation of Don Anderson as Vice President, they met on January 29<sup>th</sup> to discuss possible nominees to fill the remainder of his term. The next day, Scott asked Bjorn Olson, and he accepted the nomination. *Archives Committee:* Nothing new to report.

*Mission Endowment Fund Committee:* They met on January 16<sup>th</sup> and approved the funding items listed under the action items above.
